<u>The DHAC Facebook Page:</u> Cover page is currently our modern bandstand. Donna gave Linda a photo of the old Town Hall to replace it.

East Dunbarton Post Office: Paula presented her extensive research. Mysteries still remain. Was there ever a "cancellation stamp" for East Dunbarton as there was for the North and Center? What location(s) was the East PO in? What did the "PO operation" consist of? Paula will continue research. Donna will contact the homeowner of the Elliot-Morse House, one of the locations, and present Paula's research to discuss the potential of a new sign, hopefully with Paula. Note: This sign might entail four lines of text and exceed standard sign "stock material". Donna will contact the sign maker for advice.

Scipio Black Heritage Trail Marker: Donna has completed most of the application and is still collecting copies of all source materials. Fred and Lee will write up a potential script for the marker not to exceed 150 words. Donna will contact BHTNH to see if a November 2024 date will work for them (that was the month Scipio was granted land and also received his first Veterans flag thanks to Fred & Lee).
